EXCEPT AS MAY BE PROVIDED FOR OR AGREED TO IN SEPARATE DOCUMENTS, THE PARTIES AGREE THAT THE FOLLOWING PROVISIONS SHALL APPLY TO ANY OFFER TO PURCHASE AND ANY RESULTING AGREEMENT OF SALE COVERING ANY ITEM(S) OF PROPERTY LISTED IN THIS CATALOG.

**AWARD**: Seller, Intermountain Power Service Corporation (IPSC) reserves the right to reject any or all bids. Only the successful bidder will be notified of awards. SELLER shall notify successful bidder of bid awards within one (1) week of closing date.

**FAILURE TO PERFORM**: If for any reason whatsoever: (a) Buyer fails to make payment in full as required within fifteen (15) calendar days after notification of acceptance of bid; or (b) Buyer fails to completely remove any items from premises where sold within fifteen (15) calendar days of acceptance or such longer time as may be reasonably necessary in light of inherent difficulties in effecting such complete removal, then Buyer agrees that any agreement resulting from its offer shall automatically terminate, Buyer shall lose all of the right, title, and interest which it had or might otherwise have acquired in any items to which such failure relates, and all such right, title, and interest shall revest in SELLER. SELLER may retain all deposits or payments made with respect to such items as liquidated damages. In addition Buyer agrees to reimburse SELLER for all cost and expenses, including attorney fees, arising out of any failure by Buyer to perform hereunder.

**PAYMENT AND PASSAGE OF TITLE**: Title shall pass upon payment in full. Pending payment in full, SELLER retains a purchase money security interest in the property sold. Payment shall be made by certified check, cashier's check, or when approved, a credit memo to the SELLER upon receipt of notification of acceptance of bid, and before removing any of the items from the premises.

TAXES: Buyer agrees to pay all taxes now or hereafter imposed by law upon or on account of the sale, shipment, or use of any goods covered by this sale.

**DELIVERY AND REMOVAL OF PROPERTY**: Buyer shall remove the property at their expense within fifteen (15) working days after passage of title, unless otherwise agreed to by SELLER. Buyer shall be liable for any damage to property caused by removal operations.

RISK OF LOSS: Upon notice of SELLER'S acceptance of Buyer's bid, and prior to removal, all risk of loss, damage, or destruction from any cause whatsoever shall be borne by the Buyer, except for willful damage or destruction by the SELLER or its agents, in which event the only liability shall be to reduce the sale price applicable to the damaged goods.

**VARIATION IN QUANTITY RO WEIGHT**: Any variation in quantity or weight of any item between that listed on bid and that delivered will be adjusted on the basis of the unit price quoted for such item. No adjustment for variation will be made when property is sold on a "Price for the Lot" basis.

WEIGHING: SELLER reserves the right to witness weighing of materials on a certified public scale when material is sold on a per-pound basis.

All surplus items are sold on "AS IS/WHERE IS" basis.
