Minute Approval

Summer Party

- Scera Park in Orem: This place has an area for events with a park and pool available. James Dean will contact the events organizer to find out costs and options available.
- Thanksgiving Point: The thought here is maybe purchase passes to the different options at the venue and provide lunch at some point.
- Top Golf: This venue would be too costly.
- Splash Summit Waterpark: Pricing and availability will be investigated.
- Nephi Park and Pool: If available, the park would be a nice place to hold the Company Summer Party, however there were concerns about the pool being too small.
- Delta Soccer Field and Splash Pad: Maybe using that area for the blowups, volleyball and cornhole games.

Possibly offering tickets to the events while having lunch catered earlier in the day. James Dean suggested finding an organization that would cater the lunch for a fundraiser. It would be nice to pay an organization and benefit them if it is possible.

- Casey Draper to look into the costs and availability of bounce houses.
- Trevor Johnson to talk to the Delta Mayor about the possibility of available space during the rodeo and carnival, also if we could obtain enough discounted tickets to the rodeo to hand out to all employees.
- Joni Dutson to talk to Delta City to see if there are any community groups looking for fundraising to cater the event. James Dean will also ask the Sheriff's Posse if they would be interested.
- Rick Fowles and Kurt Sorensen will talk to Quality Market to see if they could make enough side dishes and drinks in the event they are needed.
